Perusahaan dan orang-orang yang dilarang (dimasukkan dalam daftar hitam) oleh Bank Dunia karena telah melakukan praktek korupsi dan kecurangan tidak diperbolehkan mengajukan penawaran atau berpartisipasi dalam suatu kontrak yang dibiayai oleh Bank Dunia.
